This prompted the Iraqi Oil Ministry to resort to working with licenses aimed at rehabilitating oil fields and developing their investment.

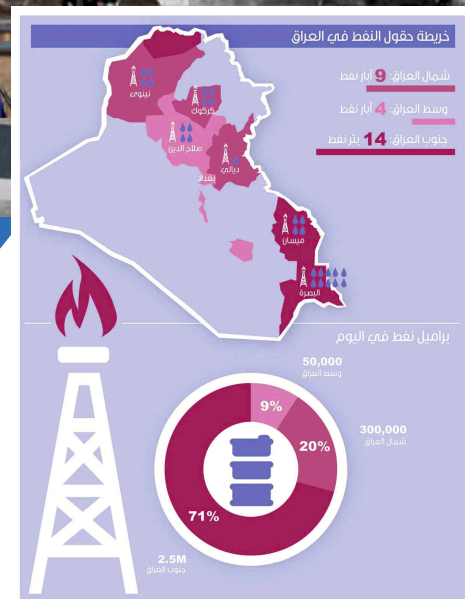




### **Exhibition schedule:-**

- The last day of the exhibition will be a gala dinner





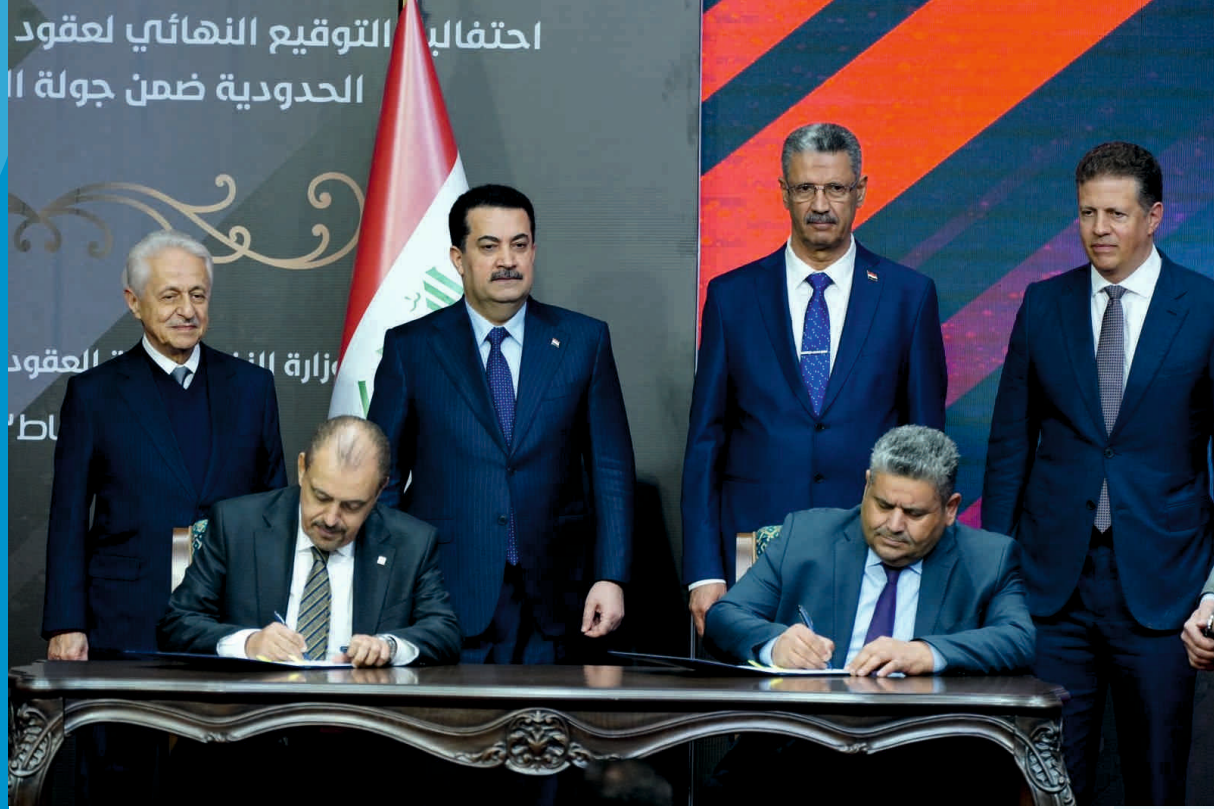




The petroleum licensing round is a set of procedures and events that begin with the decision of the Ministry of Oil to choose a number of exploration blocks and oil fields.
