Call for internal -external prices offers for consensual contracting  
to import /200/ thousand mt bread soft wheat

General Establishment for Cereal Processing, storage and Trade announces its desire to call for internal -external prices offers to import /200/ thousand mt bread soft milling wheat according to technical, legal and financial conditions book No. 49/26/7/1 dated 31/01/2022 and according to the following conditions:

- 1-Bid Bond: /6/ USD per each offered ton, or what is equivalent in Euro according to bulletin of currency prices issued by Central Bank of Syria on date of issuing the Bid Bond.
- 2- The bidder, awarded contractor, or the contractor, according to the case (from the Syrians or their equivalents) is obliged to pay the bid bonds or performance bonds from his bank account opened at one of the banks operating in the Syrian Arab Republic, exclusively by submitting a bank guarantee, a certified cheque or by bank transference from his account to the account of the Syrian Grain Establishment.
- 3- Performance Bond: (5%) of contract's value in U.S.Dollars .
- 4- Shipment period of the /200/ thousand tons is /60/ Calendar days starting from the following day of date of notifying commencement order to the Seller.
- 5- The bidder shall determine the Origin and source of goods in his offer as per the permitted origins .
- 6-Penalty of delay is /0.003/ three per mille of value of quantity delayed in shipment for each day of delay, provided that the penalty of delay should not exceed /20%/ of total value of the contract .

7-Prices should be submitted in U.S.Dollars only on basis of Cost Freight Free Out Syrian ports, on vessel's board.

8-Payment of goods value shall be settled in U.S.Dollars in coordination with Central Bank of Syria.

9-Awarded Bidder should submit a performance bond and sign the contract within /15/ days from date of notifying him with confirmation.

10- Bidder should be abided by his offer for fifteen days from the day following latest date of submitting offers.

11- Special conditions book should be bought from the establishment's foreign trade directorate in Damascus at /25/ thousands Syrian pounds.

12- Prices shall be considered final and not breakable, and any amendment on the price is not acceptable after registering the offers at the establishment's general registrar office, and bid bond for the bidder, who submits a new price, shall be confiscated.

13- Offers should be submitted in sealed envelope to the Establishment's registrar office in Damascus - Almezzeah - building of the General Company for Silos previously.

latest date for submitting offers is Monday on 14/02/2022 till 15.30 Damascus time. Opening offers shall be at /16.00/ hrs. on the same day in an open session attended by bidders and confirmation to be within fifteen days from the day following latest date of submitting offers.
